SECONDARY TRADING NOTICE

Further to the announcement and Appendix 3B released today, 453,614 fully paid ordinary Shares were issued at a price of \$0.058 per share to a service provider of the Company as part payment for drilling services rendered. The shares have been issued within the Company's existing placement capacity.

 - B. the rights and liabilities attaching to the relevant Shares.
