COMPLETION OF PLACEMENT AND CLEANSING NOTICE

Caravel Minerals Limited (ASX:CVV) (“the Company”) advises that further to its announcement of 15 July 2020, it has now completed the placement of 26,250,000 ordinary shares at an issue price of \$0.04 per Share (“Placement”). The Placement was undertaken pursuant to the Company’s available capacity under Listing Rule 7.1.

 - (B) the rights and liabilities attaching to fully paid ordinary shares.
